Please find enclosed herewith letters received from National Disaster Management Authority (NDMA), Ministry of Home Affairs, New Delki regarding the sixth meeting of NDMA chained by Hombie Prime Minister wherein it has been informed that the following steps may be taken immediately in schools:

a. Fire Fighters should go to schools and conduct demonstration exercises and give lectures.

b. In districts, essay competition and cratorical competition should be conducted for children. Essay in schools experimation should be introduced on the topic of "Disaster Management".

C. The selection of sites for construction of schools and other essential public facilities should be based on a condition of minimal threat from disasters.

d. Special Programmes may be endertaken in schools on disaster preparedness and mod drills be made part of it.

It is therefore, requested to issue necessary directions to all concerned to ensure compliance with the as we directions and furnish the action taken report to NDMA under infimation to this admistry.
