



Ministry of Skill Development and Entrepreneurship is planning to initiate a Mega Counselling exercise with the view to expose students of schools and colleges as well as dropouts to the skill eco system and provide alternate/complimentary career pathways based on their aspirations and profiles. This is a part of the larger Skill India Mission which was launched by Government of India to empower the youth of the country with skill sets which make them more employable and more productive in their work environment.

2. This counselling program has been designed such that it will entail technology for the psychometric assessment of the candidates as well as person to person session. This process has been designed such that students are given a comprehensive feedback on the career pathways. As a part of the session, the students will also be provided with the details of the nearest training centers where they can further pursue the details of the programs available.

We would like seek support from State Education Departments/Directorates for utilizing premises of State run & other affiliated Schools (Both Government and Private) and State University Campuses and its affiliated Colleges (Government and Private) for rendering counselling sessions to the both the students from the schools/colleges as well as other candidates from the vicinity. National Skill Development Corporation counselling teams shall coordinate with the nominated officers/Principals from your department for identification of space for setting up counselling camps, mobilizing of students and support for counselling the students. NSDC Counselling team shall coordinate with the nominated local officers firming up the details for counselling sessions on a mutually convenient date and time.
