

Subject: Caution regarding fraudulent activities carried out in the name of Government schemes.

Respected Sir/ Madam,

With reference to the MeitY, Government of India letter dated 18th November 2018 have issued Caution regarding fraudulent activities carried out in the name of Government schemes. MeitY have received many grievances related with digital payments and has observed that many fake agencies/ individuals are involved in fraudulent practices, in the name of Government organizations. Some of the common modus operandi observed are as given:

- a. Using name similar to Government schemes, with minor spelling change and operating "Phishing sites"
 - b. Using the logo of Government schemes, photo of Hon'ble Prime Minister, Cabinet Minister etc, in their websites.
 - c. Providing link of Government websites, to display affiliation with Government.
 - d. Alluring citizens by promising Government jobs, by issuing appointment letters on fake Government Letters, and extorting money
 - e. Misuse of Government schemes for fake allocation of Distributorship etc.
 - f. Specially targeting and building trap around latest announced Government schemes and incentives
2. Further, MeitY has mentioned that in one of the reported instance, e-gram Digital (website - egramdigital.co.in) was misusing the Government Flagship Digital India programme, for extorting money from citizens, across many States, for becoming State Distributors for fake scheme "Anka Angootha, Anka Bank" and dueling citizens

on fake payments for biometric devices. In another instance, "Yogi Ujjwala Yojana" was misused for fake allotment of LPG Distributorship with a previous website (<http://www.yjjwalayojana.org>). There is only one letter difference between "Ujjwala" and "Yjjwala". Similarly, fraudulent appointment letters were issued on the false Government letterheads.

3. MeitY, GoI has requested that all Government Ministries/ Departments/ organizations are required to take due diligence to ensure that their schemes are not misrepresented by fake/fraudulent entities for extorting money from innocent citizens. The following steps may be considered in this regard:

- i. Creation of awareness in citizens through web portal, social media and other appropriate channels, for protecting them from fake schemes and continuously posting caution messages on Facebook, Twitter etc. mentioning that the fake schemes don't belong to Ministries/ Departments etc.
 - ii. In case of identification of any fake scheme, immediate action may be taken by informing the police and concerned organizations like NCRB.
4. In view of the above, I am directed to request you for taking necessary action as per Para-3 above.
